SET-UP & LOAD-OUT: Set-up may begin as early as 4:20 a.m. on Wednesday , April 17, 2024, and must be complete no later than 9:45 a.m. on April 19,2024. motor vehicles will be allowed in approved booths. Vendor check-in will be located and arranged at AZ BUD FEST in the Budz Smoke Shop at a welcome booth. Logistics of unloading of materials for booth setup and vendor parking arrangements will be emailed to you. Setup & Materials shall be removed and cleaned from the grounds by 8:00 p.m. on Monday, April 22, 2024.

PARKING: DO NOT DRIVE ON UNRESTRICTED AREAS. Vendor accepts liability for any damage to the grounds or other public or private property.

VENDOR SELECTION: The AZ BUD FEST EVENT Committee and Budz Smoke Lounge reserves the right to refuse any vendor. Vendors are subject to limited crew per selected vendor space. More information will be provided in the welcome package. Half off general admission per additional needed crew members tickets are available. Please contact your sponsorship relations advisor for any questions.

EXPO BOOTHS: Booth size will be based on the vendor package selected. Vendors must provide a list of all occupied ambassadors at least aged minium 21, with the application. Vendors must also supply proper permits to operate at their booth. Some booths will have access to electricity. Tables and chairs will not be provided unless it is part of a vendor's sponsorship package. We have had vendors forget to bring a tent in the past; please be advised and remember it can be extremely hot in early April. Coolers are recommended .If needing tent supplies please contact: (430)-388-FEST must give at least two week notice prior to April 19,2024.

CONDUCT, SAFETY RULES & REGULATIONS: AZ BUD FEST prohibits the right to No firearms , or unrelated CANNABIS or CBD products are allowed to consume or have on the premisis durning the event. Alcohol will be available in a non consumption cannabis area. No guest is allowed to bring in alcohol. Alcohol will be served in the back patio zone and will not be allowed in the building. All Vendors must have at least one member supervising there booth at all times durning the start and finish of the BUD FEST . In case of an emergency there are three exit located in the lower building . Maps will be provided in welcome package. AZ BUD FEST EVENT is a Peace oriented event. Behavior unsuitable for the Festival, or which constitutes a public nuisance, will not be permitted. AZ BUD FEST EVENT STAFF in their discretion shall determine whether an act is unsuitable. Anyone displaying inappropriate conduct will be asked to leave and restricted from the event! Any Vendor providing samples are agreeing that they legally posses the right to produce the consumption of cannabis. GOVERNING LAWS: This Agreement shall be governed by the laws and the health, sanitation and fire regulations of the State of Arizona and any county regulations.

BUSINESS LICENSE & SALES TAX: A business license is not required to be a vendor at AZ BUD FEST . All sales taxes are the responsibility of the Vendor. The Committee and AZ BUD FEST EVENT assume no liability for the collection of sales tax or other governmental fees.

SECURITY: Security will be fully enforced and guest will be check for any weapons, firearms , or harzards things apound entry. Wrist bands and badges will be strictly impose, giving the only access granted to the BUD FEST and must be worn at all times. Anyone without a wrist band or badge will be asked to leave. Vendors are responsible for the security of their own property and equipment at all times. No security personnel will be assigned specifically to Vendors. The AZ BUD FEST EVENT shall not be held responsible for any loss, theft or damage to any property left on the grounds at any time.
